# **Illegal logging and timber trade**

#### Approximately over 50% of tropical timber worldwide <u>still</u> comes from illegal sources

#### Context

- Governments of several consumer markets have introduced strict regulations on timber trade to address the problem of illegality (EUTR, Lacey Act).
- Timber traders must ensure the legality of the timber through processes of due diligence and risk assessment before placing it in the consumer market.

#### **BVRio's approach**

To comply with these regulations, since 2014 BVRio has developed:

- Tools and guidance to differentiate between legal and illegal timber.
- A marketplace to source legal timber supplies to meet their demand requirements.



## **Responsible Timber Exchange**

Founded in 2016, this free online trading platform is used to promote the use of tropical wood products from legal sources.



#### Available in 6 languages

English, Portuguese, French, Chinese Mandarin, Bahasa Indonesia, and Spanish.

## **Producer Country Events 2016-2020**

August 2016, Peru: Presentation in the Workshop 'Strengthening Forest Control Systems and Market Chains in APEC Economies'.

March 2017, Ghana: Regional Workshop on 'Legality and Sustainability in the Timber and Agricultural Commodity Supply Chains', attended by 65 participants from Ghana, Liberia, Brazil, and UK.

March 2017, Brazil: Presentation in the TFA General Assembly, "Forest risk in supply chains – a dialogue on how to practically manage risks"

May 2017, Liberia: Timber legality workshop presenting the RTX, attended by 41 participants from timber companies and government institutions, with very positive feedback from the Forestry Development Authority (FDA).

August 2017, Indonesia: Presentation of the Responsible Timber Exchange Platform as a tool to help promote FLEGTlicensed timber products from Indonesia on the international markets, attended by 10 representatives of the timber industry and certification bodies.

September 2017, Indonesia: Roundtable 'Online Trading Platform for Legal and Sustainable Wood Products', attended by 35 participants representing producers, associations, social enterprise, certification bodies, and the Indonesian Government

September 2017, Cameroon: Workshop to promote legal timber trade in the international and domestic markets, organised the workshop in partnership with WWF, Proforest, and The Cameroonian Ministry of Forest and Wildlife, with a total of 32 participants.

February 2018, Ghana: Responsible Timber Trade Fair in Ghana in collaboration with the Timber Industry Development Division (TIDD) of the Ghana Forestry Commission as part of the 27<sup>th</sup> Ghana International Trade Fair in Accra, 55 participants attended.

September 2018, Indonesia: Responsible Timber Exchange Outreach event in Surabaya, in collaboration with FSC Indonesia. Representatives from 18 timber companies attended.

March 2019, Indonesia: Good Wood Expo trade fair event, attended by 117 participants and recruiting new subscribers to the RTX, adding an amount of 64,208 m<sup>3</sup> of FLEGT-licensed Indonesian timber.

November 2019, Republic of Congo: Workshop titled 'Promoting legality in the timber sector in Republic of Congo', attended by 47 participants, including representatives from the Ministry of the Forest Economy, timber companies and civil society.


